1 Purpose

2 Background

The documents brought for review form a central part of the corporate governance framework of the Trust taken alongside the Trust's Constitution; its Provider Licence; the Accounting Officer Memorandum and its codes of conduct.

3 Changes and key issues for 2023-24

- 3.1 Revisions in this year include updated references to the Code of Governance for NHS Provider Trusts published in October 2022 and coming into effect from 1 April 2023.
- 3.2 The new code of governance includes best practice guidance in relation to the chair of Audit, and a restates the role of the Audit Committee. The updated code can be accessed here: Code of Governance. Following discussion, the recommendation from the Audit Committee is that this change is reflected as the 'ideal' and which would allow for this change to be brought into effect following the end of the term of the current Audit Committee Chair in March 2024. The Board is asked to support this approach.
- 3.3 Copies of the documents are attached in the reference pack and changes to documents are summarised in Appendix 1.



3.4 In addition, following the Committee reviews the Executive were asked to consider the ED membership and attendance requirements for each committee and to consider whether this needed any further review.
