Introduction

Climate change poses a major threat to our health as well as our planet. The environment is changing, that change is accelerating, and this has direct and immediate consequences for our patients, the public and the NHS.

The NHS is responsible for 6.3% of England's total Carbon Emissions and 5% of the air pollution, taking into account the consequence of poor air quality to health, the NHS has a social and ethical responsibility to take Sustainability seriously, driving forwards with plans for reduction.

Some of the hardest opportunities to realise in reducing NHS emissions come from changing patient and staff behaviour, for example by reducing use of cars compared to other transport, changes in behaviour are not easy for many people – for example, alternative transport may not be at hand – and they will require support.

Plastic Pledge

The OCS team have implemented the #ThinkPlastic pledge within catering, who have replaced plastic straws and sandwich bags in catering outlets.

Following the move to Cambridge the Trust has not used any plastic plates, cutlery, straws or stirrers.

We will continue to look at other areas where we can make reductions. The pledge initially focusses on single use plastic in catering areas, however further elements encourage review of other areas where we can reduce single use plastic. The implementation of reusable gowns is an example of one such initiative undertaken.

Developing the Papworth Green Plan

To develop plans to achieve and where possible exceed targets set out in the "For A Greener NHS" Programme, we are launching the Royal Papworth Sustainability plan. This launch was planned for earlier in the year but events relating to COVID meant the postponement of the Trust launch.

The Trust have recently appointment a dedicated Sustainability Officer and the Trust will look to develop a Sustainability Board with various working groups and focus. The sustainability board members will work across the organisation with colleagues in key areas to identify where changes can be implemented.

The Trust have joined the regional Sustainability Network, and the National Performance Advisory Group meetings, there are a number of steps associated with developing the plan which are detailed at high level on the next slide.
